



The Myth of “Six Million”

Author Don Heddesheimer's book, ***The First Holocaust: Jewish Fundraising Campaigns With Holocaust Claims During and After World War One*** (and as pdf-file), is an important piece of the revisionist puzzle. Heddesheimer cogently documents the slew of previous attempts by Jews to disseminate deceitful and untrue atrocity propaganda **before, during and after World War I**. *The First Holocaust* features an amazing collection of press clippings and propaganda articles dating back to the late 19th century that make claims of the suffering and imminent extermination of European Jewry. Among such articles we find that Jews have, dozens of times before WWII, invoked the cabalistic "6,000,000" number as the amount of Jews on the verge of death and destruction during various periods of turmoil and conflict in Europe and Russia. YOU SHALL RETURN

In the days when slavery existed, the Torah decreed that there must come a time when every man goes free. Even those who resold themselves after six years of servitude, and had their ears pierced for voluntary enslavement, could not remain beyond the time of the Jubilee.

These are the words chosen to be inscribed on the Liberty Bell. It is in the Jubilee year that "ye shall return every man unto his possession and ye shall return every man unto his family."

The Hebrew word for "ye shall return," תשובו (TaShuVU), seems to be spelled incorrectly. Grammatically it requires another ו (vav). It ought to read תשובו (TaShUVU).

[Quote 2] Regarding the ‘six million’ number you should know the following: In the Hebrew text of the Torah prophecies, one can read “you shall return”. In the text the letter “V” or “VAU” is absent, as Hebrew does not have any numbers; the letter V stands for the number 6. Ben Weintraub, a religious scientist, learned from rabbis that the meaning of the missing letter means the number is ‘6 million’. The prophesy then reads: You will return, but with 6 million less. 1900-

American Zionist leader, [Rabbi Stephen S. Wise](#), let slip the Zionist agenda behind the Holocaust Hoax: to promote public sympathy for Zionism (Jewish takeover of Palestine).

RABBI WISE'S ADDRESS.

Rabbi Wise said, in part:

"The day will never come when I will care less for Zion, when there will be any one who will strive more for the glorious ideals of Zionism.

"Two great conventions of Jews are being held to-night. In Chicago there is a conference of charities called together by men who minister to the wants of the poor. They have assembled to see that too much charity is not given to the unworthy. Their purpose is right. But ours is the greater charity. We have assembled not to see that the Jew does not get too much, but that every Jew shall get the right to live.

"There are 6,000,000 living, bleeding, suffering arguments in favor of Zionism. They come not to beg, but ask for that which is higher than all material things. They seek to have satisfied the unquenchable thirst after the ideal. They ask to become once again the messengers of right, justice, and humanity.

"Your Christian friends will honor you if you have enough self-respect to care for your own people. Say that you are not a Jew, and you will be hated as a Jew, nevertheless. But say that you are an American Jew, and strive for the best principles of the race, you will be respected and the Zionist name honored.

"Of Israel and Zion one thing is true. They can conquer. God is our leader, and with the General of the heavenly hosts to lead who will say that we go not to victory?

"In the old Greek games, the man who won the race was not he who went fastest, but the one who bore a lighted torch to the end of the course.

"We Zionists have entered a race, the torch of liberty, charity, and justice in our hands.

"The race will be won, not because we are fastest but because that lamp is a light unto the world. It will never be extinguished.

"Come, brethren, the lamp is in your hands; run the race and may God give you the victory forever."

Other speakers were Dr. M. Mintz, Dr. Robert L. Halperin of Chicago, and the Rev. Dr. F. Drachman.

The Zion hymn by the Rev. Dr. H. Perelra Mendes, was sung at the conclusion of the speaking. The band of the Hebrew Sheltering Guardian Society Orphan Asylum, under direction of I. L. Fauerbach, played a number of selections.

1902-

Under its entry on “anti-Semitism”, the tenth edition of the Encyclopedia Britannica references “Six Million Jews” of Rumania and Russia being “systematically degraded.”

While the main activity of anti-Semitism has manifested itself in Germany, Russia, Rumania, Austria-Hungary and France, its vibratory influences have been felt in other countries when conditions favourable to its extension have presented themselves. In England more than one attempt to acclimatize the doctrines of Marr and Treitschke has been made. The circumstance that at the time of the rise of German anti-Semitism a premier of Hebrew race, Lord Beaconsfield, was in power first suggested the Jewish bogey to English political extremists. The Eastern crisis of 1876-1878, which was regarded by the Liberal party as primarily a struggle between Christianity, as represented by Russia, and a degrading Semitism, as represented by Turkey, accentuated the anti-Jewish feeling, owing to the anti-Russian attitude adopted by the government. Violent expression to the ancient prejudices against the Jews was given by Sir J. G. Tollemache Sinclair (*A Defence of Russia*, 1877). Mr T. P. O'Connor, in a life of Lord Beaconsfield (1878), pictured him as the instrument of the Jewish people, "moulding the whole policy of Christendom to Jewish aims." Professor Goldwin Smith, in several articles in the *Great Britain*, Baron de Hirsch founded a colossal scheme for transplanting persecuted Jews to new countries under new conditions of life, and endowed it with no less a sum than £9,000,000 (see HIRSCH, MAURICE DE). Though anti-Semitism has been unmasked and discredited, it is to be feared that its history is not yet at an end. While there remain in Russia and Rumania over six millions of Jews who are being systematically degraded, and who periodically overflow the western frontier, there must continue to be a Jewish question in Europe; and while there are weak governments, and ignorant and superstitious elements in the enfranchized classes of the countries affected, that question will seek to play a part in politics.

LITERATURE.—No impartial history of modern anti-Semitism has yet been written. The most comprehensive works on the subject, *Jews among the Nations*, by A. Leroy-Beaulieu (1895), and *L'Antisemitisme, son histoire et ses causes*, by Bernard Lazare (1894), are collections of studies rather than histories. M. LAZARE's work will be found most useful by the student on account of its detached standpoint and its valuable bibliographical notes. A good list of works relating to Jewish ethnography will be found at the end of M. Isidor Loeb's valuable article, "Juifs," in the *Dictionnaire universel de bibliographie* (1884). 1905-

END OF ZIONISM, MAYBE.

Jewish Preacher's View of Uprising in Russia.

The Rev. Dr. M. H. Harris spoke in the Temple Israel, Fifth Avenue and One Hundred and Twenty-fifth Street, yesterday morning at the regular services on the "Russian Situation." He prefaced his remarks by reference to the Testaments and to history to show that the people had gradually received a larger sphere of freedom from nations and Governments for the exercise of their powers and duties.

He declared that a free and a happy Russia, with its 6,000,000 Jews, would possibly mean the end of Zionism, since the abolition of the autocracy would practically eliminate the causes that brought Zionism into existence.

Russia, he said, seemed to prefer its own bloody experience in learning the power of the people to profiting by the experience and the history of other nations.

POBIEDONOSTZEFF, RESIGNS.

**Chief Procurator of the Holy Synod
Most Hated Man in Russia.**

ST. PETERSBURG, Oct. 31.—Constantine Petrovitch Pobiedonostzeff, Chief Procurator of the Holy Synod, has resigned.

Constantine Petrovitch Pobiedonostzeff, now in his seventy-eighth year, has been a prominent factor in the internal life of the Russian Empire for the last fifty years, and is the most hated man in Russia to-day.

Since his appointment as Procurator General of the Holy Synod, in 1880, he has persecuted the Jews, Lutherans, Catholics, and other dissenting sects with an unswerving fanatical zeal. From 1890 to 1902 he caused 6,000,000 Jewish families to be expelled from Russia and sent thousands of Poles to Siberia. His watchword was "Russia for the Orthodox Russians." Cossacks were ordered to surround the Catholic churches in Poland and shoot down the congregations as they came out.

Dr. Paul Nathan's View of Russian Massacre

STARTLING reports of the condition and future of Russia's **6,000,000 Jews** were made on March 12 in Berlin to the annual meeting of the Central Jewish Relief League of Germany by Dr. Paul Nathan, a well-known Berlin publicist, who has returned from an extensive trip through Russia as the special emissary of Jewish philanthropists in England, America, and Germany, to arrange for distribution of the relief fund of \$1,-500,000 raised after the massacres last Autumn.

Dr. Nathan paints a horrifying picture of the plight and prospects of his coreligionists, and forecasts at any hour renewed massacres exceeding in extent and terror all that have gone before. He left St. Petersburg with the firm conviction that **the Russian Government's studied policy for the "solution" of the Jewish question is systematic and murderous extermination.**

Dr. Nathan read to the meeting a circular addressed to the garrison of Odessa, calling upon the soldiers to "rise and crush the traitors who are plotting to upset the holy Government of the Czar and substitute for it a Jewish empire." → 

He concluded with an appeal to the Jewish money powers of the world to arrest Russia's career as a borrower. The financiers of the world should call a halt to Russia, not only for humanitarian reasons, but for practical reasons. Russia's bankruptcy is an established fact, he added.

As a side note: 1906 was the year after the first Jewish-led Communist uprising in Russia had failed. This lame sob story was nothing more than a ploy to distract public attention from the fact that the Communist-led upheaval that took place in Russia a year earlier was the handiwork of his fellow Jews who perpetrated widespread atrocities against Russian patriots (anti-Communists).

1908-

WASHINGTON OFFICE

The Washington Office has been continued, and has, as heretofore, proved of great usefulness in keeping your Committee informed of affairs in Washington.

RUSSIA

The position of our co-religionists in Russia grows increasingly deplorable, and recent advices from that country indicate that there is little likelihood of any relief being afforded.

The situation is of the gravest. It may be doubted whether Jewry has ever confronted a greater crisis since the overthrow of the Jewish state by the Roman Empire. Not even the horrible persecutions of the times of the Crusades or the expulsion from Spain and Portugal affected so large a mass of our co-religionists. Russia has since 1890 adopted a deliberate plan to expel or exterminate six millions of its people for no other reason than that they refuse to become members of the Greek Church, but prefer to remain Jews. To carry out this purpose, it has used several methods. Wholesale assassinations (called pogroms), have been employed in order to arouse the religious fanaticism, the greed, and the savagery of the needy, the ignorant and the depraved among the Russian people. Horrible as these pogroms are, their effects are trivial compared with those which have followed other methods countenanced by that Government. The Jewish inhabitants of the congested Pale of Settlement are being harassed by restrictions on their ordinary activities, by practical denial to a serious extent of the right to educate their children, and by having thrust upon them by force, large numbers of their co-religionists who had settled in other places within the Empire and had there been usefully employed. By this insidious process, the Russian Government wickedly and artificially creates unnatural conditions that enable it to twist economic and social laws into the service of persecution, and it believes that by their operation the ultimate expulsion or destruction of the Jews of Russia is assured. From the point of view of that Government, this method has the further advantage that it avoids the cry of horror

1911-

Max Nordau, co-founder of the *World Zionist Organization* together with Theodore Herzl, made an astonishing pronouncement at the tenth Zionist Congress in Basle, Switzerland. He claimed that 6,000,000 Jews would be annihilated. This was twenty-two years before Hitler came to power and three years before World War I started.

As distinct from this attitude of Weizmann stood the alarm of Max Nordau and Vladimir Jabotinsky.

In the Zionist Congress of 1911, 22 years before Hitler came to power, and three years before World War I, Nordau said, "How dare the smooth talkers, the clever official blabbers, open their mouths and boast of progress. . . . Here they hold jubilant peace conferences in which they talk against war. . . . But the same righteous Governments, who are so nobly, industriously active to establish the eternal peace, are preparing, by their own confession, complete annihilation for six million people, and there is nobody, except the doomed themselves, to raise his voice in protest although this is a worse crime than any war . . ."

Vladimir Jabotinsky, in 1936, declared: "It is not our task to establish in Palestine a home for *selected people*, not even a state for a small portion of our people. The aim of our efforts is to organize a systematic *massive Jewish evacuation* from all the countries in which they live . . ."

And in April, 1940, he declared in New York, "The transfer of millions of Jews to their homeland will *save the European Jewry from extermination*," and again, "*evacuation of the masses is the only cure for the Jewish catastrophe*."

American Committee Tells of Suffering Due to the War.

The American Jewish Relief Committee, called into being at a conference of more than 100 national Jewish organizations which was held at Temple Emanu-El on Oct. 25 to consider the **plight of more than 6,000,000 Jews** who live within the war zone, has elected Louis Marshall Chairman, Cyrus L. In the United States there are between 2,000,000 and 3,000,000 Jews, nearly all able to do something and yet, after months of work, we have not raised more than \$300,000. In New York there are more than 1,000,000 Jews, some of them persons of great affluence, but many of them seem to think if they give a few hundred dollars they have done their duty.

"We hear of pogroms in Russia, in Poland, in Galicia, and yet we sit indifferent. In Palestine starvation stalks through the land. Shall we selfishly enjoy ourselves and say we would like to, but cannot help because of hard times, and think we are doing our duty? No. The time has come for every man and woman and child to do his duty, and we must fulfill that duty quickly or it may be too late in hundreds of thousands of cases."

From across the sea six million men and women call to us for help, and eight hundred thousand little children cry for bread.

These children, these men and women are our fellow-members of the human family, with the same claim on life as we, the same susceptibility to the winter's cold, the same propensity to death before the fangs of hunger. Within them reside the limitless possibilities for the advancement of the human race as naturally would reside in six million human beings. We may not be their keepers but we ought to be their helpers.

In the face of death, in the throes of starvation there is no place for mental distinctions of creed, no place for physical differentiations of race. In this catastrophe, when six million human beings are being whirled toward the grave by a cruel and relentless fate, only the most idealistic promptings of human nature should sway the heart and move the hand.

Six million men and women are dying from lack of the necessities of life; eight hundred thousand children cry for bread. And this fate is upon them through no fault of their own, through no transgression of the laws of God or man; but through the awful tyranny of war and a bigoted lust for Jewish blood.

In this threatened holocaust of human life, forgotten are the niceties of philosophical distinction, forgotten are the differences of historical interpretation; and the determination to help the helpless, to shelter the homeless, to clothe the naked and to feed the hungry becomes a religion at whose altar men of every race can worship and women of every creed can kneel. In this calamity the temporalities of man's fashionings fall away before the eternal verities of life, and we awaken to the fact that from the hands of one God we all come and before the tribunal of one God we all must stand on the day of final reckoning. And when that reckoning comes mere profession of lips will not weigh a pennyweight; but deeds, mere intangible deeds, deeds that dry the tear of sorrow and allay the pain of anguish, deeds that with the spirit of the Good Samaritan pour oil and wine in wounds and find sustenance and shelter for the suffering and the stricken, will outweigh all the stars in the heavens, all the waters in the seas, all the rocks and metals in all the celestial globes that revolve in the firmament around us.

Race is a matter of accident; creed, partly a matter of inheritance, partly a matter of environment, partly one's method of ratiocination; but our physical wants and corporeal needs are implanted

In all of us by the hand of God, and the man or woman who can, and will not, hear the cry of the starving; who can, and will not, take heed of the wail of the dying; who can, and will not, stretch forth a helping hand to those who sink beneath the waves of adversity is an assassin of nature's finest instincts, a traitor to the cause of the human family and an abjurer of the natural law written upon the tablets of every human heart by the finger of God himself.



the 77th Division alone there were 14,000 of them, and in Argonne Forest this division captured 54 German guns. This shows that at Argonne the Jewish boys from the United States fought for democracy as Joshua fought against the Amalekites on the plains of Abraham. In an address on the so-called "Lost Battalion," led by Colonel Whittlesey of Pittsfield, Major-General Alexander shows the fighting stuff these Jewish boys were made of. PITIFUL PICTURE DRAWN

Appeal Issued for Mothers
Driven Insane by Seeing
Children Starved

By NATHAN STRAUS

NEW YORK, October 18.—Terrible as conditions have been for the last five years among the destitute Jews of Eastern Europe, they have never before been so appalling as they are at the present moment. With the coming of winter the climax of tragedy has been reached, according to the latest reports from American Jewish relief workers, in every part of these stricken countries. At no time since hostilities ceased has the suffering been so intense as it is now among the Jews in these unfortunate lands. Six million Jews, out of the 16,000,000 in the world, or considerably more than a third of the entire Jewish race, are today standing in bread lines or getting the soup on which they live from the soup kitchens of the Joint Distribution Committee of American Funds for Jewish War Sufferers.

ORPHANS LIVE ON STREETS

Thousands of them are sick, hundreds of thousands are without homes—all are destitute. A hundred thousand Jewish orphans, many of whom are sleeping and living on the streets, look forward with terror to the coming of the winter. It is impossible to compute the number of mothers who have gone insane as they watched their children starve or the number of typhus patients who are praying for death as they lie sick, without hospitals or medicines or sufficient food.

One year more of malnutrition has so weakened these poverty-stricken Jews that they will not be able to endure the rigors of the winter even as well as they did last year, when thousands of them died from cold and hunger. The number of refugees has been greatly increased also by the Bolshevik fighting, and innumerable homes have been destroyed within the last twelve months.

Hundreds of thousands of Jews are living today in open fields or unroofed platforms, fifteen families to a platform, in broken houses, in stalls of old stables or in holes in the ground. They are clad, for the most part, in the rags they have worn for the last five years, with strips of cloth bound to their feet or bits of bark tied to their soles to serve as shoes.

Every month this summer 27,000 Jewish children were sent to vacation homes to recover their strength, depleted by starvation. Last month 500 additional children were sent from Vienna to Holland, where private homes were to receive them and 500 other invalids were sent from Vienna to Trieste to convalesce.

Extensive as it seems, the aid now being given children in Eastern Europe does not nearly meet the need, and unless funds are raised to carry on the work on an infinitely greater scale, the coming spring will find comparatively few children alive in these stricken lands. Herbert Hoover of the American food commission, who just returned to America, commented upon this fact, and said that it would have been impossible for the food commission, to have kept between 4,000,000 and 5,000,000 children in Eastern Europe alive even until now without the help of the American Jewish Relief Committee's funds.

There is no corner of Poland, Lithuania, Rumania, Czecho-Slovakia, or Palestine so remote that the Joint Distribution Committee of American Funds for Jewish War Sufferers has not reached it with some supplies for the unfortunate populace, either Jews or Gentiles or both. A relief train of forty-four cars recently carried food and old clothing and bedding to a number of towns in Siberia. Eight motor trucks, laden with crackers and condensed milk, are even now following upon the trail of the Bolsheviks in Poland as they retreat, in order to save the people still left alive from death by starvation. All this work must be continued.

UKRAINIAN JEWS AIM TO STOP POGROMS

Commission to Visit Europe and
Prepare a Memorandum for
President Wilson.

LANSING GIVES PERMISSION

Mass Meeting Hears That 127,000
Jews Have Been Killed and
6,000,000 Are in Peril.

The Federation of Ukrainian Jews in America, an organization said to represent three-quarters of a million Ukrainians in this country, decided at a convention yesterday that the massacre of their brethren in Eastern Europe must finally be stopped, and, to bring about this peace, the aid of the United States Government will be utilized. Secretary of State Lansing, it was asserted, has already given the consent of the State Department for the federation to send a commission to Ukraine to investigate the conditions of the Jews there, and to establish direct connection between them and their relatives in America.

The convention was held at the Broadway Central Hotel, at Broadway and Third Street, and was attended by more than 800 persons, representing 300 branches of the organization in this country and Canada. Joseph Seff, the President, was Chairman. Addresses were delivered by the Rev. M. Kanewsky, Rabbi Z. Masliansky, Jacob Adler, Herman Bernstein, Dr. Samuel Bucher, Rabbi Meier Berlin, Mordecai Danzic, the Executive Secretary of the society, and others.

Tales of massacres in which 127,000 Jews had either been killed or wounded during the last six months were told by the speakers, and all of them, speaking in English, Yiddish, Polish, or Russian, pointed out the disgrace of these pogroms upon twentieth century civilization.

The matter of relief was taken up, and it was decided that the Federation of Ukrainian Jews request this Government to lift the blockade so that food and funds may be sent to their destitute relatives in Eastern Europe. The President reported that there were 3,000,000 Jews in Ukraine and a like number in Poland, all of whom were in need of assistance from America.

Before Ukraine should be recognized by America or any of the other allies, it was said that she should first desist from her persecutions of innocent Jews. Until the commission which is to be appointed shall have reported that the Jews are actually receiving equal rights, friendly relations should not be made. It was urged.

The commission, which will probably consist of ten of the leading Ukrainians in America, is to work out a memorandum of the conditions in Eastern Europe, which will be sent to President Wilson, Secretary Lansing, and to all Senators and Congressmen.

An information bureau will also be established by the organization to take care of the reports of the commissioners on the other side, and to send the facts to the press of this country. The Federation also aims to act as the link joining the Ukrainians in this country with their relatives and friends in their native land.

Demonstration mass-meetings similar to the one which took place at Madison Square Garden some time ago will be held in every important city in the United States, as the beginning of a protest movement to put an end to the pogroms across the seas.

When the question of appointing a commission was proposed Reuben Pink, the representative of the society at Washington, said that he had seen Secretary Lansing during the week and that he received Mr. Lansing's consent that the delegation be sent over.

"We come out now before the world with the determined slogan, 'Those pogroms must stop,'" said the President in his annual message. "It is only a question of holding these facts continually before the civilized world; we must not permit the world to slumber. This fact that the population of 6,000,000 souls in Ukraine and in Poland have received notice through action and by word that they are going to be completely exterminated—this fact stands before the whole world as the paramount issue of the present day."

SIX MILLION PERISH IN SOVIET FAMINE

Peasants' Crops Seized, They and Their Animals Starve

Like barnyard fowl, two peasant women garner kernels of grain spilled in snowing. They must do this to keep alive in a land of plenty—the Ukraine.

Here 6,000,000 children, women and men have died of starvation. The women were permitted, as a great privilege, to pick the kernels.

Russia's beautiful thoroughbred horses, known the world over, are used now in the agricultural districts. The animals, needed on every farm, are dying off by the million of starvation.

Reporter Risks Life to Get Photographs Showing Starvation

STARVATION stalks through the Ukraine section of Soviet Russia, leaving a ghastly trail of death and agony. The Ukraine is the most fertile grain-producing district in Russia.

The facts contained in the series of articles, of which this is the first, were obtained by Thomas Walker, an American newspaperman, now resident in London, at the peril of his life.

When Mr. Walker entered Russia last Spring he smuggled in a camera.

While the photographs shown with these articles were obtained under the most adverse and dangerous possible circumstances, the evidence they present is most grim and graphic than words.

I HAVE recently visited the Ukraine district of Soviet Russia, where 6,000,000 peasants have perished from starvation in the past eighteen months, due to the excessive tolls made on their crops by the Bolshevik government.

Last Winter, Red Army soldiers, under orders from Moscow, took so much of the season's crops from the peasants that they were unable to feed themselves and their livestock through the Winter.

Editor's Note: Commentators have declared Dr. Weizmann's speech before the Royal Commission in Palestine, an address which lasted some 2½ hours to be the greatest declaration regarding Palestine since the issuance of the Balfour Declaration. "I should like to present a tried statement of the background and motives behind the Zionist movement, which seeks the establishment of the Jewish National Home in Palestine. The stimulus and hope which animate Zionism cannot be understood without relationship to the position of the Jewish people in Central and Eastern Europe, where six million Jews are in a position which is neither life nor death. Only recently the Foreign Minister of Poland said that there are one million Jews too many in Poland. It is difficult to understand why Jews who had lived in Poland for a thousand years, shared its vicissitudes and made their contribution to the growth of the country

DR. WEIZMANN BEFORE ROYAL COMMISSION

FROM OUR CORRESPONDENT

JERUSALEM, Nov. 25

Dr. Chaim Weizmann, the Zionist leader, presented the historical and moral background of Zionism to the Royal Commission at its public session to-day.

He explained that the Jewish problem was two-fold. First was the "homelessness" of the Jews. While in Western Europe many individual Jews had happy homes, in Eastern Europe there were 6,000,000 unwanted unfortunates who were condemned to be penned up in places where they could not live. Even those in Western Europe were now threatened. Second was the world problem created by the presence of these 6,000,000 people without a future whose condition was a threat to Europe. A certificate permitting emigration to Palestine was regarded as a certificate of freedom.

Referring to the past history of the Jews, Dr. Weizmann claimed that there had never been a time when the Jews did not try to return to Palestine. He said that England had been interested in the project for 300 years and that the Balfour Declaration had been no more than a final link. That Declaration had not been a matter of "War expediency," but was a serious step in the culmination of long discussions. Originally the Jews had plainly understood the Declaration to mean the restoration to them of Judea as a Jewish State.

The Government had reminded them of their obligations towards others in the country, but the Jews could honestly say that these others had indirectly benefited by the work they had done.

THE "NATIONAL HOME"

Although the Jews regarded the limitation of immigration to the absorptive capacity of the country as an inadequate interpretation of the "National Home," yet the officials of the Jewish Agency had loyally adhered to the formula: but to limit immigration for other reasons was unthinkable. It was felt that there was an unlimited opportunity for expansion by the use of what was called uncultivable land; but unless the Government adopted a positive and dynamic policy Jewish work would be slow.

He defended the desire of the Jews to refrain from employing Arabs as they wished to make their home with their own hands, and in concluding said that the Jews had reluctantly opposed the establishment of a Legislative Council as a premature scheme which would be used by the Arabs to hinder the creation of the "National Home."

WASHINGTON, May 30.—A petition addressed to Prime Minister Stanley Baldwin expressive of the hope that Great Britain will steer a course favoring the establishment of a free Jewish nation in Palestine such as would provide refuge for millions of persecuted Jews in Eastern Europe and Germany was presented to Sir Ronald Lindsay, the British Ambassador, today by a Christian delegation representing the Pro-Palestine Federation of America and headed by the Right Rev. James F. Freeman, Episcopal Bishop of Washington.

The petition, in expressing the opinion of enlightened Christian leadership in the United States, favoring a larger Jewish immigration into Palestine, stressed the intolerable sufferings of the millions of Jews in "the European holocaust."

Urges Definite Policy

It suggested the need for a clear and definite policy on the part of the British Government in the carrying out of the stipulations of the Palestine mandate.

The "sincere belief" was voiced that, in a time when bigotry and prejudice seem "to have engulfed a major portion of the civilized world, the Anglo-Saxon community of nations is called upon to blaze the trail for the dawn of a new era of freedom, justice and human enlightenment."

The petition was signed by Samuel Harden Church, president of Carnegie Institute, Pittsburgh, Pa.; Dr. S. Parkes Cadman, president of the the Union of Congregational Churches in America; Ivan Lee Holt, president of the Federal Council of Churches of Christ, St. Louis, Mo.; Frederick B. Robinson, president of City College, New York; John Haynes Holmes, Community Church, New York; W. R. Hopkins, City Manager, Cleveland, Ohio, and George Gordon Battle, New York.

The Pro-Palestine Federation of America is a national organization of American Christian sympathizers and supporters of the Jewish national home cause, with offices at 307 Fifth Avenue, New York.

Text of Petition

The text of the petition follows:

The plight of millions of human beings in Eastern Europe and Germany has stirred the conscience of enlightened mankind. Mere compassion and commiseration with the sufferings of these victims of prejudice and persecution, however, are not enough.

Bold practical measures to save these unfortunate millions from total annihilation are now called for. It is the consensus of enlightened Christian American opinion that God has bestowed upon England one of the greatest missions in human history—

the salvation of Israel and restoration to its ancient patrimony. Great Britain has it within her power to throw open the gates of Palestine and let in the victimized and persecuted Jews escaping from the European holocaust.

Enlightened Christian opinion in America is now eager to see the provisions of the Palestine mandate carried out. It is eager to see the settling of the Jews in the land facilitated in accordance with the stipulations of the mandate. Above all it would welcome the removal of any impediments and obstructions to the social-economic development of the country, which untimely and premature projects of self-government would cause, in the present condition of the country.

Recognizes Problems

We are mindful of the complex and difficult task faced by His Majesty's government in Palestine. We also appreciate the anxiety and sincerity with which the Palestine Government is grappling with the problems there. We, however, feel that the right solution calls for a definite policy, which should, once and for all, make clear to the turbulent element in Palestine that His Majesty's government, as mandatory power, will carry out its trust to help transform Palestine into a Jewish homeland to which the persecuted Jews of the world may freely come, and where they may have the right to constitute themselves into a free nation.



DR. WEIZMAN STRESSES JEWS NEED OF NORMAL NATIONAL LIFE

Jews Reject Minority Status in Palestine

LONDON, Monday (Palestine).—In his opening address at the talks on Palestine in St. James's Palace last Wednesday evening, (which has now been officially released for publication) the President of the Jewish Agency, Dr. Chaim Weizmann, declared that the Jewish representatives had entered upon the discussions in the desire to be helpful and with full recognition of the difficulties facing the British Government.

They must, however, safeguard the vital interests and rights of the Jewish people which could not be surrendered, particularly in this blackest hour of Jewish history. He referred to his survey before the Royal Commission in Jerusalem in November, 1936, indicating that the root of the problem lay in the homelessness of the Jewish people who were everywhere a minority.

The Jewish people had preserved their identity because of their attachment to Palestine and the hope of the return to Zion. They claimed that Palestine had never been abandoned, and the Jewish community there had never ceased to exist; in every age Jewish groups had gone to Palestine, and during the last 60 years active re-settlement had been going on.

HISTORIC RECOGNITION

The Balfour Declaration, the Zionist President proceeded, had recognised these historic facts; and in the preamble to the Mandate, international recognition was "given to the historical connection between the Jewish people and Palestine, and the grounds for reconstituting their National Home in that country."

Reviewing developments since the Royal Commission, Dr. Weizmann referred to the fact that the members of that Commission, which had consisted of men in the front rank of British public life, had after long and careful enquiries found that when issuing the Balfour Declaration the British Government had realised that, given the necessary zeal and enterprise by the Jews, a Jewish State in the course of time would be established in Palestine.

The Royal Commission had proposed a Jewish State in part of Palestine, a plan which was adopted by the Government and caused heart-searching among the Jewish people. But, although they did not regard the original promise as fulfilled, the Jews agreed to explore the possibility of cooperating with the Government on this basis because the principle of the Report, acknowledged by the Government, was that the creation of a Jewish State "would secure the establishment of a Jewish National Home and relieve it of the possibility of being subjected in the future to Arab rule. It would convert the Jewish National Home into a Jewish State with full control of immigration."

These two main principles, Dr. Weizmann submitted, retain their binding and moral force.

He went on to say, "The Royal Commission's report outlined artificial restrictions on Jewish immigration and

the relegation of the Jewish community to minority status. It is inconceivable that, after 20 years, the British Government should be seeking an interpretation of the Mandate which would curtail fundamental Jewish rights. Such a departure from the moral position would shake the British Empire to its foundations, for the bonds riveting it together are purely moral, composed of mutual faith and belief in the security of promises."

But a new period of vacillation ensued, resulting in the Woodhead Commission's Report, and the idea of a Jewish State was abandoned. The one thing that remained was the political high level imposed on Jewish immigration.

At a time of intense distress to Central European Jewry, and when the Jewish tragedy was spreading to other countries, the gates of the National Home were almost shut to Jewish refugees. The fate of six million people was in the balance: they knew not whether to go.

The Jews had been told that the Balfour Declaration and the Palestine Mandate had not contemplated large-scale immigration. Even historically that statement was inaccurate. There had been intense Jewish suffering and persecution in Russia in pre-war days, and hundreds of thousands of Jews had emigrated annually. Jewish distress was always one of the two foundations of the Zionist Movement, the other being the need of the Jews for a normal national life of their own in their historical home.

GOVERNMENT TACTICS AT LONDON CONFERENCES

LONDON, Monday. — In what Dr. Weizmann, in his speech on Wednesday which was officially released tonight, described as the darkest hour in the history of the Jewish people, the British delegation, in its negotiation with both the Jewish and the Arab representatives, is now settling down to the consideration of fundamentals.

The Arabs are evidently persisting in their effort to prove that the MacMahon pledge included a promise of independence for the Palestine Arabs. This case was argued on Saturday and again today by Nuri Pasha es Said and will be continued tomorrow by the Prince of Saudi Arabia and Yemen, still centering on this point, which Mr. R. A. Butler is expected to clear up from the point of view of the Government.

It is also apparent that the Government delegates pursue the strategy of wearing down whichever delegation happens to be facing them, by presenting the Jewish arguments to the Arabs, and vice versa. It is difficult to predict what the Arabs hope to gain by scoring a dialectic victory in the MacMahon controversy, except perhaps to underline the alleged conflict of rights, but the argumentation against the background of St. James's Palace, with its hallowed tradition and its crimson carpets and cushions, is punctuated by the unceasing murders on the Palestine front itself. The Arab delegates would appear to be endeavouring to demonstrate the rights of their claims by appalling wrongs, such as the weekend casualty toll which is tucked away in remote columns in today's London newspapers.

ARABS' "RIGHTS"

The Jews acquiesced to the talks, although they expected no benefits to result from them; they are now forced to defend their rights, which were guaranteed by the entire civilised world, against the so-called natural rights of the Arabs, which presumably include the right to doom the Jews to extinction. The restitution of the Jews to their homeland which is the true and only meaning of the Mandate is now conditional, in the Arab view, but worse still perhaps also in the British view, on the consent of the Arabs, and not only of the Palestine Arabs, but also of the Arab States.

The MacMahon dispute will not end in the creation of an Arab State in Palestine — that is certain, but one delegate's shrewd forecast is a Government compromise, with or without consent, promising the Jews that the Arabs will not be given a State, and the Arabs that the Jews will not be given immigration.

It was essential, the statement continued, that there should be one place in the world where the Jews would not be an adjunct, but masters of their own destinies. Various well-intentioned projects were now being sponsored to find a territorial base in other countries for the Jews, but no other undeveloped country can give immediate relief to large numbers of refugees, and a long period of experiment was required in any new country.

The signal success of Palestine was due to the national and religious fervour behind the endeavours which could not be evicted in other countries. Moreover, Palestine had been prepared by 40 years of pioneering work and was now capable of taking in hundreds of thousands of refugees. If Palestine was unable to absorb all Jews in search of a refuge, that was hardly a logical reason for saying that it must take less than it can take.

Dr. Weizmann pointed out that Jewish work had not stood still even under the difficulties of the past three years. In spite of the danger, Jewish labour in Palestine and parents had sent their children. He also referred to the degree of defence which the Jews had been able to render for their own settlements and also in helping the British military forces.

CONFLICTING PROMISES

Referring to the alleged conflicting promises made to the Jews and the Arabs, Dr. Weizmann pointed out that there was no conflict concerning Western Palestine, as had been acknowledged by representatives of the British Government and by Sir Henry McMahon himself. The late Colonel T. E. Lawrence had also recorded that Mr. Winston Churchill's settlement in 1917-22 had fulfilled all the British promises towards the Arabs.

Lastly, the late King Feisal, the authorised spokesman of the Arabs at the Peace Conference in Paris, had accepted the Balfour Declaration.

Where there was a possibility of a conflict between the promises in respect of Trans-Jordan, this was solved 100 per cent in favour of the Arabs. The Arabs had emerged from the last War with four Kingdoms. Their statehood came easily through the expenditure of British blood and effort. As the Royal Commission had pointed out, so far as the Balfour Declaration had contributed to the victory of the Allied Powers, it had also contributed to the liberation of the Arabs.

"It is relevant to compare," he declared, "what the Arabs have made of the extraordinary opportunities given them with little trouble, and what the Jews made of the chances offered them. Your Arab territories stand empty today — an invitation to powerful and unscrupulous Powers."

DIFFERENT APPROACHES

Dr. Weizmann emphasized the difference in the importance of Palestine to the Jews and to the Arabs, quoting the report of the League's Permanent Mandates Commission as follows:

"The collective suffering of the Arabs and Jews cannot be compared, since vast spaces in the Near East, formerly the abode of a numerous population and the home of a brilliant civilisation, were open to the former; whereas the world was being increasingly closed to the settlement of the latter."

As for the Arab claim that Palestine was an Arab country and must have an Arab Government, even the present basis of the claim could not be realised, as the Jews formed a third of the population and were responsible for more than two-thirds of the economic and cultural activities in Palestine.

NON-DOMINATION

The Jews did not want to dominate the Arabs, he said, but they would not allow themselves to be dominated by them, and they would not submit to the same fate as the Assyrians of Iraq.

The gist of Dr. Weizmann's statement was a demand for the continuation of the Mandate and of Jewish immigration in accordance with the principle of absorptive capacity, an active policy of development, and effective safeguards against a minority status.

The Zionist President concluded: "I pray that you, who have carried justice, fairness and good government into the most remote corners of the globe, — I pray with all respect and humility, that you do justice to my people in this dark hour."

He ended with the statement that it was true that Palestine was a Holy Place for the Arabs as it was also for the British, but it had never been a national centre for the Arabs as was Damascus.

East and Central Europe. Other warnings of the same dire character have been uttered by Nazi officials and publications for the past several years.

Today, two-thirds of the Jewish population in Poland is under Nazi occupation. Even the infrequent dispatches from the war front indicate that the Jews were the twofold victim of Nazi hatred and retaliation, first as citizens of Poland, and secondly, as Jews. The Nazi propaganda machinery is feverishly at work in an effort to drive a wedge between the Jews and the Poles. In line with its set policy, pursued before the hostilities commenced, Nazi propaganda attempts to convince the Poles that their enemy is the Jew and not the Nazi aggressor. At the same time, an effort is made to portray the Polish civilian resistance as stemming mainly from Jews, in order to justify wanton retaliation and goad the German soldiers and civilian population to more frightful acts. Frequent bombardments of Polish towns have been directed in many cases at the Jewish quarters. Polish Jews knew that their very existence is at stake in this war. For the part of Poland, occupied by the Nazis, there may be a puppet government, Slovak style, pending a change in fortune. For Jews there is but death, exile and persecution. Nor is there any escape for them. If the pattern established by the U.S.S.R. will be followed in the regions occupied by the Russian forces, Jews in these localities will face persecution for their religious beliefs, Zionist activities and democratic sympathies.

As was not the case in the last war, in which the Jews of Germany shed blood for the glory of the grateful "Vaterland," they are held there today as hostages to become again the scapegoats in the event of the defeat of the Nazi forces.

The problem of Palestine has attained a new complexion against the background of the new world situation. It continued to loom large until the outbreak of hostilities. It was evident from the utterances and actions of the Colonial Minister, Mr. Malcolm MacDonald, that the British Government was determined to put into effect the measures outlined in the White Paper, and to break the resistance of the Jewish community. This was reflected in the suspension of Jewish immigration into Palestine during the six months beginning October 1, 1939, as a retaliation for the continuous stream of "illegal" immigration of German and other refugees. Jews were heartened by the publication of the report of the League of Nations Permanent Mandates Commission, four of whose seven members declared the White Paper an unmistakable violation of the terms of the Mandate. In the meantime, attention was shifted to Geneva where the Twenty-First Biennial World Zionist Congress was opened on August 16.

The Congress met under the threatening clouds of war, a circumstance which influenced both the procedure and the tenor of the addresses and discussions. Because of the emergency situation in Zionism, elections were not held in a number of countries. The labor group was strongly represented as usual, and its coalition with the liberal General Zionists (Group A) still dominated the scene in spite of minor disagreements. The major differences which transcended all group lines ranged about the type of resistance to be undertaken against the British policy. While the Congress went on record as unanimously opposed to any compromise in Palestine at the expense of Jewish rights.

WHAT IS HAPPENING AND WHAT YOU CAN DO_____

The following article is an excerpt from "Let My People Go," a pamphlet written on Christmas Day, 1942, in London. While it is addressed to Englishmen, its message applies to Americans as well.

Of the **six million Jews** or so who were living at the outbreak of the war in what is at present Nazi-occupied Europe, a high proportion—between one and two million—have been deliberately murdered by the Nazis and their satellites.

No discrimination has been made in favor of **pregnant women, babies, children**, the sick, or the very old. On the contrary, discrimination, such as it is, has been in favor of men from whom an adequate last ounce can be got in German war factories.

The murders have taken the form of **random shootings, mass shootings, mass electrocutions**, mass poison-gassing, and transportation in conditions which inevitably involve death during the journey. This is over and above slow starvation by the allotment of hopelessly inadequate rations, or no rations at all.

This treatment has been carried out with the greatest conceivable inhumanity, and **has involved the maximum of hopelessness and despair**. In particular, helpless children have had to face the fear of a torturing death without the strengthening sympathy of their parents. In particular, helpless children have had to face the fear of a torturing death without the strengthening sympathy of their parents, and their parents have had to know that they were doing so. All this is part, not of war, but of a quite deliberate policy, openly proclaimed, of exterminating the Jewish population of Europe.

This policy, which has been pursued since the outbreak of the war, has been greatly speeded up during the last few months. It is now reaching its climax. *Unless something effective is done*, within a very few months these **six million Jews will all be dead**, except the fifty thousand or so in the countries at present neutral, and perhaps a few tens of thousands whom Hitler may find it convenient to work to the last ounce of their strength in his own war


the moral sense of civilized men and made them callous to human misery. Perhaps the roar of gigantic battles had drowned out the sound of helpless voices behind the ghetto walls. But whatever the reason, the fact remains that the Jewish tragedy in Europe was passed over as just another "episode" in a global war.

Suddenly, during the summer of 1942, world public opinion was shocked out of its lethargy by the realization that the Nazis had decreed the complete extinction of six million Jews and that a third of the victims had already perished. The response to this deliberate savagery was a mighty outcry of protest, indignation and mourning on the part of Jews and non-Jews, governments and social agencies, churches and the press in all free countries. Eleven United Nations, among them the United States, Great Britain and Soviet Russia condemned "in the strongest possible terms the bestial policy of cold-blooded extermination."

In countries throughout the world Jews observed a day of mourning by fasting and praying. Heads of the Christian religion, both Catholic and Protestant, appealed to world conscience to rise in sympathy with the martyred Jews. Labor in many countries halted work, and decent people everywhere, in one way or another, called for retribution, justice and restoration of Jewish rights after victory. This demonstration of human sympathy in the midst of a global war was an act of striking historic significance.

SIX MILLIONS MURDERED

MOSCOW, Monday (UP). — The Soviet State Publishing House is preparing the publication of another "Black Book," a documentary record of the German massacre of approximately six million European Jews.

According to the Soviet editors, the Germans killed between five and six million Russian, Polish and Western European Jews, and an additional half million are being murdered in Hungary now.

Of Poland's pre-war Jewish population of 3,100,000, about 250,000 were known to be in Russia. All of the others, who had been under German rule, were killed with the exception of 8,000 escapees, the editors estimated.

In many of the reoccupied areas, the Russians found intact records listing the names and origin of victims along with identification certificates, passports, and photographs.

Signatures on the tea-stained letter were illegible. (Radio Moscow announced Sunday that German Field Marshals Von Leeb and George von Kuechler and seven generals had been named along with the "Hitlerite government" and the "German high command" as war criminals responsible for 46,000 atrocities in Estonia. A Pravda editorial broadcast by Moscow said "these criminals cannot escape responsibility" and added that the guilt of Alfred Rosenberg, Nazi minister for occupied eastern territories, had been "established on the same ground.")

JEWISH RALLY URGES GAS ATTACKS ON NAZIS

Immediate action for the rescue of the surviving Jews in Europe, including the use of poison gas against Germany, was demanded at a "rebirth of a nation" rally in Town Hall last night under the auspices of the American League for a Free Palestine.

Peter H. Bergson, chairman of the Hebrew Committee of National Liberation, which seeks recognition of a Jewish nation as an ally of the United Nations, with representation on the various Allied councils, was the principal speaker.

Referring to repeated warnings by Prime Minister Winston Churchill and President Roosevelt that poison gas will be used against Germany if the Nazis use it against any member of the United Nations, Mr. Bergson pointed out that a million Jews had been reported killed by poison gas in Nazi concentration camps.

"Since poison gas has been used against the co-belligerent Hebrew nation, we of the Hebrew Committee of National Liberation publicly demand of the American and British Governments that unless this practice ceases poison gas be used against Germany," he declared.

**Jacob Lestchinsky Estimates
Reduction in Europe Since '39**

The Jewish population in Europe has been reduced from 9,500,000 in 1939 to 3,500,000, it was estimated yesterday by Jacob Lestchinsky, exiled economist and newspaper man, in an address at the nineteenth annual conference of the Yiddish Scientific Institute. Mr. Lestchinsky, who is research secretary of the institute, spoke at the closing sessions of a three-day conference at the Hotel Park Central and attended by delegates from Jewish educational and cultural groups.

"Of the 6,000,000 European Jews who have died, 5,000,000 had lived in the countries under Hitler's occupation," he said.

Other speakers included Dr. Harry M. Orlinsky, Professor of Bible at the Jewish Institute of Religion; Prof. Abraham Heschel of Hebrew Union College, Cincinnati, and Joseph Opatoshu, vice president of the institute's executive board.

Ilya Ehrenburg, a notorious Jewish Propagandist in the USSR who agitated for genocide against Germans and incited the mass rape of German women by the Red Army, prematurely proclaimed that “the world now knows that Germany has killed Six Million Jews” before anyone could have known that was the number.

Wolves they were—

I HAVE spent two weeks in Germany—terrors, flames, smoking Germany, where long wander in and out of deserted town halls, and the wind reflects the tatters of municipal banners emblazoned with eagles, lions and swags. We might guess and say: By seven days' night—if make were not beneath us. For us, this is the triumph of justice.

Many, when they talked of tribulation, thought only of the chances of some future treaty. One thing is certain. Fascist abominations will find no defenders, judicious champions of "equilibrium"—equilibrium between light and darkness.

This May Teach Them

But whenever our idea of the future peace may be, one thing is clear—reminiscence has begun. Germany has come to learn what war means. And who knows?—perhaps these weeks and months of war on German soil will make a far deeper impression on German memories than any treaty stipulations.

Friday they even salute our homes. World conqueror? Why, the nation never entered their heads! I was present at the inauguration of Colonel Hiccuph. At first he kept repeating: "Germany is invincible." Then, as if some spring had run down, he proceeded in an entirely different voice: "How can you call me a Nazi? Why, I was married to a Jewess!" Yes, they are trying to get rid of their past. "I am a Frenchman!"—I have seen Aryan blood in me—"My mother was a Dutchwoman."

The girls gaze at the smiling Red Army men ingenuously, hesitantly, as if they were robust visitors instead of conquerors.

Splitting on the Butcher

The Germans know all the orders of our military commandments. "On the instructions of Herr Russian Commander," they say proudly.

They inform against one another: "The best butcher is an active Nazi!"—"They'll murder me!"—"Willy the stubborn killed a Polish woman!"—"Fran Schmidt received the thanks of the gendarme himself!" They all try to prove their innocence. One brought a certificate to show that thirteen years ago the Hitlerites killed him for a month. Another produced a testimonial signed by his ex-slave, a Russian war prisoner. A third dug up a membership card of the social democratic party, dated 1919.

A woman in trousers climbs up the front of a building to restore a window sign. No one ordered her to do it. She is all ecstasy and grief. She thinks she has established herself in the eyes of

reflex, hands and daggers at the order of some camouflaged obersturmführer or rutenführer.

I have not genuine remorse in a single German—only fear and prudence.

If there are any creatures at all to be pitied on the roads of Germany, it is only the tiny beset children, the crumpled, sunken, and the abandoned cats and dogs. These alone had no share in Germany's atrocities. All honour to the Soviet soldier who does not believe in the magic of blood, to whom an infant is an infant.

We are not fighting children and old women—we are not Fascists. We have come to Germany not to vent our feelings, but to eradicate the very memory of the vampire state.

The homes of the hangers-on, the accomplices, furnished with portraits of Hitler and gaudy grilles, in Munich the beer halls have been special tables marked with flags "for regular shows."

During the war they have accumulated all sorts of knick-knacks from Paris and Rotterdam, Potsdam and Moscow—there, their homes are regular two-to-three storeys. I heard a Red Army man, talking over a rapid front porch: "One could live all right in a dog house."

But no. It was not enough for them. Gaudy shows their wealth: the Guts and Tang, to

Wolves they remain

small, provincial Rastenburg not only the wealthier, but even workers' families had their Russian armchairs. After all, there was no need to pay for anything.

The German agricultural Museum reviewed the Prussian landowners, and dreamed of fabled Prussian estates. For had one French tank pressed every Prussian a handsome allowance of Russian food? German writers believed that the German people were uncomprehending and fanatical, a share of the spirit would fall to them.

How in Germany the corrupting influence of Fascism is plainly evident, and it is not only in the life between the depots and the depot. The last one, "present from the one." What did he need with these two Ukrainian slaves? Read the notices on his walls: "Obedience is your richest possession."—"The day for world war, the day for a pleasant sleep!"—"A tale ends never comes alone!"

The two snakes don't seem united to the German subliminal. But in the end he has his son on the floor, and he also has his workshop, his bed and his entire German home.

"We Are Innocent"

They can put their watches forward, they can pull down the "Hitlerstrasse" Street signs, but the damning evidence remains at every turn, and cannot be destroyed.

A French army doctor, fired by the Red Army, said to me: "Of course, the Germans behaved brutally to us, too. But we lived like gods compared with the Russians. We tried to share our food with them, but the Germans sent us to

the Gradens punishment camp, if they caught us at it. They said: "If you help Bolsheviks you are betraying the sides of the new Europe."

No. Germany cannot disprove her crimes by putting the clock forward.

The world now knows that Germany has killed six million Jews. Do they think it is enough for them to take down the street signs, for their atrocities to be forgotten? They swear: "We knew nothing about it. We are innocent." But the evidence is there. They ran away from us in such a hurry that they discarded not only their city banners, not only their official seals and police records, but even their personal papers.

Kindergarten Songs

I looked in vain in Loetzen, Rastenburg and Tapan for a public library. There wasn't such a thing. I found only one museum—in Bartenstein. What did it contain? Portraits of Hindenburg and the opulent of an officer of the racist army, labelled: "Victory at Tannenberg."

The other exhibits were the uniform of a Polish officer and a photograph of the ruins

of Warsaw, the skeleton of an ape, not less than a hundred portraits of Hitler, a horning of the time of Rimbaud, and a photograph of a housewife of the town. That was the sum total of the "museum."

Loetzen has a splendid school building. I found in one of the desks a song-book intended for juvenile supermen, containing the words and music of: "Merrily fall the bombs on England!" "Let Jewish blood flow," and "Let the Bolsheviks writhe at the sound of our drums." On the classroom wall was an immense portrait of Hitler with a little satellite of five or six standing in front of him, holding a toy gun.

Allied Prisoners' View

One could not live in such a den! Culture is not measured by vacuum cleaners or mixing machines. We are proud to have set the face of the least infamy.

I have spent many hours in cordial conversation with men freed by the Red Army—Frenchmen and Poles, Englishmen and Austrians, Belgians and Serbs, Netherlands and Greeks, Americans and Chinese. Some are loquacious, others taciturn, some are dark, some fair, some are grim, others are loud. But I have not met among them a single defender of the Germans.

The people who have been liberated by the Red Army know what Soviet Russia means. These people from a dozen countries, journeying from captivity, yearn not for any delusions—equilibrium between good and evil, but for the triumph of justice.

BERN, May 12 — At least one point in Adolf Hitler's "Mein Kampf" program has been carried out thoroughly — the bestial extermination of European Jews.

Of the eight million Jews living in Germany and German occupied countries before the war, 6,200,000 have died from either execution, cruel treatment or starvation, according to latest figures compiled by Jewish welfare organizations here.

500,000 Left in Reich

In Germany, where the great majority of European Jews had been concentrated, only 500,000 are alive today—and the word "alive" is a mere figure of speech. Now that the story of their suffering can be told without harming the survivors, it may be pointed out that the martyrdom of Europe's Jews ran through three phases.

The first was the period of "extermination" proper from the time of the declaration of war on Russia until the end of 1942. Millions of Jews were taken to the camps at Auschwitz, Maidanek and Treblinka which boasted the most modern gas execution chambers and crematories for bodies. The SS hordes invading Russia were instructed to shoot all Russian Jews wherever they were encountered.

The Weak Disappear

By the end of 1942, however, Germany felt the need for foreign labor and the remaining able-bodied Jews were sent to work camps. The women, old men and children all disappeared into the gas chambers.

The slavery of the able-bodied and the execution of the frail continued until the beginning of 1944, by which time the Nazis had reached the saturation point of their cruelty. More than five million Jews had been liquidated and the remaining ones were no longer regarded as a "problem," as Hitler saw it.

In addition were the transport difficulties making human ship-



take advantage, at a time when Hitler was most anxious to keep the whole of eastern Europe quiet until his preparations against the U.S.S.R. were complete. The situation was made worse by the total failure of the invasion of Greece and by the rapid retreat of the Italians in North Africa before Sir Archibald Wavell's advance (Dec. 1940). Hitler was obliged to come to the aid of his axis partner. He sent German reinforcements to North Africa (where Erwin Rommel succeeded in driving the British back in the spring of 1941), and he took steps in readiness for a German invasion of Greece. Hungary and Rumania had already been reduced to the status of German satellites and made no difficulties about the movement of German troops toward the Greek frontiers; nor did Bulgaria, where, after a sharp diplomatic contest with the Russians the Germans proceeded to occupy key positions throughout the country in March. The remaining Balkan country, Yugoslavia, was induced under pressure to accede to the tripartite pact in March 1941, but the Yugoslav government was overthrown by a palace revolution in the name of the young king Peter. Thereupon Hitler ordered drastic measures to make an example of Yugoslavia. In the course of April 1941 German forces invaded both Yugoslavia and Greece, the former operation being accompanied by brutal air attacks on the defenseless city of Belgrade. By the end of the month both countries had been occupied, and in the last half of May German parachute troops completed the Balkan campaign by the capture of Crete.

Invasion of the Soviet Union.—With the occupation of Crete and Rommel's success in driving back the British to the Egyptian frontier, Raeder and others urged that the situation was ripe for a decisive blow against the whole British position in the middle east. But Hitler was set upon attacking the U.S.S.R. and insisted that all other operations must be postponed until it had been defeated, a task which he confidently expected to accomplish within six or eight weeks.

The invasion began on June 22, 1941, and in the opening stages of the campaign the German army drove deep into Soviet territory. Despite imposing successes, however, the Germans failed to achieve a decisive victory and by dispersing his forces Hitler left the frontal assault on the Soviet armies defending Moscow until late in the year. At the beginning of Dec. 1941, the onset of the dreaded Russian winter and the unexpected Soviet counter-offensive faced the German high command with a major military crisis. This brought to a head the strained relations between Hitler and the army leaders. Since the reluctance of the high command to undertake offensive operations in the west in the winter of 1939-40, Hitler had become increasingly critical of the generals, and was less and less prepared to listen to their advice. In Dec. 1941 he dismissed Gen. Walther von Brauchitsch, the commander in chief of the German army, and assumed the direct command of the armies in the field himself. The fact that by drastic measures he succeeded in holding the Soviet attacks during the winter greatly increased his confidence in his own military genius. Henceforward he refused to listen to any views, or even information, which ran counter to his own conception of how the war should be conducted.

Germany Declares War on the United States.—The Japanese attack on Pearl Harbor in Dec. 1941 now extended the war to the whole world. Hitler promptly declared war on the United States, whose resources he underestimated as grossly as those of the U.S.S.R. He failed however to grasp the unity of the war or the importance of seapower and in his growing preoccupation with

abilities at an earlier stage.

Hitler had shown an equal blindness to the importance of the Mediterranean theatre of operations. At the close of 1942, the advance of the British 8th army from the east and the joint Anglo-U.S. landings in northwest Africa were driving the German and Italian forces under Rommel into a trap. Hitler now hurriedly made available the reinforcements he had earlier refused, but without being able to halt the Allies' advance; the only result was to increase the size of the forces captured in Tunisia, where more than 250,000 German and Italian troops surrendered in May 1943.

Meanwhile, in the east, ignoring the warnings of his professional advisers, Hitler had embarked on still more ambitious operations for the campaign of 1942, aiming at the occupation of the Caucasus oil fields in the south and a drive to the Volga in the south-east. The invasion of the Caucasus fell short of its objective, while the drive to the Volga turned into a desperate contest for the city of Stalingrad, where Hitler's obstinate refusal to withdraw in time led to the encirclement and capitulation of the German armies under Field Marshal Friedrich von Paulus at the end of Jan. 1943.

The double defeat of Stalingrad and Tunisia represented the turning point of the war. By mid-1943, Hitler had lost the initiative and from that time the German forces everywhere stood on the defensive.

The Nazi Empire.—At the height of his success, Hitler was the master of the greater part of the European continent. German rule in the east was extended to wide areas of the Baltic states, Byelorussia, the Ukraine and European Russia; Poland (part of which was annexed, the rest organized as the government-general) and the protectorate of Bohemia-Moravia; Serbia and Greece (where the occupation was shared with the Italians); and the nominally independent, satellite states of Slovakia, Croatia, Hungary, Rumania and Bulgaria. In the west, Norway, Denmark, the Netherlands, Belgium and France were all under German occupation, part of France from the summer of 1940 and the whole country from Nov. 1942.

German economic exploitation of these territories was ruthless. The needs of the native population were subordinated to the demands of the German economy, often at the cost of widespread hunger and shortages, while German industrial and business firms as well as officials made the most of the advantages the situation offered. In eastern Europe German policy treated the population not only as conquered peoples, but in accordance with Nazi teaching, as inferior races without rights, fit only to serve as slaves. Those classes of the population which on account of their education or position might be expected to provide leadership, together with the Jews and any who showed signs of resistance, were put to death. At Mauthausen, one of the extermination camps in Austria, close to 2,000,000 people, mostly Jews, were exterminated between 1941 and 1945; at Orszecim (Auschwitz) in Poland, 2,500,000 were executed in the gas chambers, while another 500,000 died from starvation and disease. Frequent man hunts were carried out to round up labour for deportation to Germany; at the end of 1944, 4,795,000 foreign workers had been recruited in this way, the three largest groups being Russians (1,000,000), Poles (851,000) and French (754,000). Those from the east were treated entirely as slave labour and the conditions under which they lived were often appalling. Hitler's and Himmler's plans for the new order they meant to build in eastern Europe were only

The influential Zionist leader Nahum Goldmann, co-founder and long-time head of the World Jewish Congress, publishes a book about Jews, *The Jewish Paradox*. of the situation, Germany was already so powerful that there was no longer anything to be done.

Apart from my encounter with the survivors of the concentration camps after the liberation, I only returned officially to Germany in order to meet Chancellor Adenauer and open negotiations about reparations. These reparations constitute an extraordinary innovation in terms of international law. Until then, when a country lost a war it paid damages to the victor, but it was a matter between states, between governments. Now for the first time a nation was to give reparations either to ordinary individuals or to Israel, which did not legally exist at the time of Hitler's crimes. All the same I must admit that the idea did not come from me.

During the war the WJC had created an Institute of Jewish Affairs in New York (its headquarters are now in London). The directors were two great Lithuanian Jewish jurists, Jacob and Nehemiah Robinson. Thanks to them, the Institute worked out two completely revolutionary ideas: the Nuremberg tribunal and German reparations.

The importance of the tribunal which sat at Nuremberg has not been reckoned at its true worth. According to international law it was in fact impossible to punish soldiers who had been obeying orders. It was Jacob Robinson who had this extravagant, sensational idea. When he began to canvass it among the jurists of the American Supreme Court they took him for a fool. ‘What did these Nazi officers do that was so unprecedented?’ they asked. ‘You can imagine Hitler standing trial, or maybe even Goering, but these are simple soldiers who carried out their orders and behaved as loyal soldiers.’ We therefore had the utmost trouble in persuading the Allies; the British were fairly opposed, the French barely interested, and although they took part later they did not play any great part. The success came from Robinson managing to convince the Supreme Court judge, Robert Jackson.

The Institute's other idea was that Nazi Germany ought to pay after its defeat. That still required belief in the defeat, at a time when it seemed likely that the war in Europe was lost for the Allies, but like Churchill and de Gaulle I kept my faith. I never

doubted for a moment, because I knew that Hitler would never manage to moderate himself and that his excesses would draw the Allies into the conflict. According to the Institute's conclusions, the German reparations would first have to be paid to people who had lost their belongings through the Nazis. Further, if, as we hoped, the Jewish state was created, the Germans would pay compensation to enable the survivors to settle there. The first time this idea was expressed was during the war, in the course of a conference in Baltimore.

Once the Nuremberg trials were over, this reparations problem received further consideration. Several Jewish leaders then attempted to establish relations with Adenauer, but their proposals were often ridiculous. One organization suggested a payment of twenty million Deutschmarks—and at the conclusion of the agreement I obtained, the Germans will have paid out a total of eighty billion!

Our ‘contacts’ were Walter Hallstein, then an under-secretary of state, and later president of the EEC, and the diplomat Herbert Blankenhorn, director of the political department of the German Foreign Ministry and Adenauer's right-hand man. These two have remained close friends of mine.

During a meeting of the World Jewish Congress in London, a Russian Jew called Noah Barou, a wonderful man and great idealist whose premature death was a severe blow, talked me into taking an active part by first of all meeting Adenauer. I was very hesitant at heart, because it was no easy matter for me to talk to the Germans again. And in fact it was eventually my head, and not my heart, which decided me to negotiate. But I laid down a pre-condition: before I would meet the Chancellor to open negotiations, Adenauer had to make a solemn statement to the Bundestag; he must say that although the Germany of those days was certainly not the Germany which had produced Auschwitz (Adenauer himself had been in prison under Hitler, and then had to hide in a monastery because the Gestapo were looking for him), it nevertheless inherited the Nazis' responsibilities, and reparations were its duty; he must add that material reparations could not erase the evil done to the Jews by the Germans.

Israel's Holocaust Museum, rebutting a common belief, said yesterday that the Nazis never made soap from human fat of murdered Jews during the Second World War.

"Historians have concluded that soap was not made from human fat. When so many people deny the Holocaust ever happened, why give them something to use against the truth?" said Shmuel Krakoski of the Yad Vashem Museum.

Israeli Holocaust historian Yehuda Bauer said there is no evidence Nazi Germany used corpses for soap, although it did use skin for lampshades and hair for mattresses.

He said many Jews believed murdered families had been turned into soap because the Nazis themselves propagated the idea as "a sadistic tool for mental torture."

Holocaust expert rejects charge that Nazis made soap from Jews

TEL AVIV — Professor Yehuda Bauer, head of the Yad Vashem University's Holocaust Memory department and regarded as one of the foremost researchers of the Holocaust, has denied the long-quoted charge that the Nazis used the bodies of Jewish death camp victims to make soap.

The isolated possibility for transforming human fat into soap were not known at that time, Bauer said Sunday at a Holocaust memorial evening for Yom Hashoah.

The camp literatures were prepared to believe any horror story about their persecutors, and the Nazis were content to let them go on believing the reports, he said.

"The Nazis did enough harm by doing during the Holocaust; they do not have to go on believing untrue stories," Bauer said.

Unsubstantiated rumors about the use of bodies of Jewish victims to make soap had circulated during both World War I and World War II, he said.

Rene Hilberg, professor of political science at the University of Vermont and a Jew, admitted at the Holocaust, agrees that the soap rumors, although widespread, were probably unfounded.

"There were all kinds of rumors," he said, noting that a New York Times article during the war suggested that Jews were given lethal injections before deportation and arrived at the extermination camps already dead.

Other rumors speculated that Jews were killed in the Belzec camp by starvation in order to make soap from their bodies.

"All of these rumors are untrue, based on nothing at all," Hilberg said. "No evidence has turned up" to suggest that the Nazis used human fat to make soap.

In Danzig, Germany (now Gdansk, Poland), pictures of dead, bereaved people cut into pieces and a corpse for soap were discovered in 1945 at the Stutthof camp. "But we don't know that the bodies were of Jews, so that the pictures and soap went to pieces," said Hilberg.

Moreover, the rumor was being circulated as early as 1942, according to documentary evidence.

"It's fairly reliable that the story was circulated, but I can't say whether or not it is true," said Hilberg.

Nazis never made human-fat soap

Yad Vashem, the Israel Holocaust Memorial Authority, last week upheld the recent statement by Professor Yehuda Bauer, an eminent Holocaust historian, that the Nazis never made soap from human fat.

No documentation exists to back up such allegations against the Nazis, Yad Vashem spokesman Menachem Fogel said.

"That is the position Yad Vashem has always held."

Bauer, a professor at the Hebrew University and head of the International Centre for Research on Anti-Semitism, said at Wizo House in Tel Aviv, "The Nazis never made soap from Jews because they did not have such technology."

Shmuel Krakoski, archives director at Yad Vashem, explained that the reason many believed, and still believe, that the Nazis made such soap was because during the war the Germans started rumours to that effect.

"What is clear is that soap was made on which the letters RIS were inscribed, and there was propaganda that this soap was made from Jews," said Krakoski. RIS supposedly stood for *Rein Jüdische Seife*.

The Nazis did however use the skin and hair of humans to make various products, said Krakoski.

Bauer said that the Nazis carried out many atrocities and there was no need to add false allegations to their already dark record.

Despite this admission, there are still Jews today going around claiming that this actually occurred.

Two Zionist Holocaust promoters, Deborah Lipstadt and Professor Peter Novick, both have stated in their books that Simon Wiesenthal, the infamous "Nazi hunter" and pathological liar, outright invented the "five million non-Jewish deaths" that supposedly happened in the Holocaust as a marketing ploy to garner interest of Non-Jews in the Holocaust religion, also known as "Holocaustianity."

The revisionists estimate that the combined death toll in all German concentration camps was somewhere between 300,000 to 500,000. Of that amount about half the victims were Jews. Jewish Suffering and Armenia

To the Editor of The Tribune.

Sir: Reading your editorial of the 11 "Armenia," in which you rightfully condemn the Turks for the execution of Armenians, I wish to ask you what about Russia?

What the Turks are doing to Armenia is child's play compared to what Russia is doing to **six million Jews**, her own subjects. This at a time when about half a million Jewish soldiers are fighting for the Tsar, many of whom have been decorated, and shows their faithfulness. When the war returns home, cripples for the rest of their lives, they find their homes gone, wrecked by an outside enemy but by the very government they served, their parents killed, exiled, their wives and sisters dishonored, their children starved and wandering.

Such things happened to tens of thousands in Russia is doing it to-day, and yet there is outcry from the American press. It was the Ambassador to Turkey (by the way, himself a Jew) who protested against these massacres of Armenians. Was there any such protest from the American Ambassador in Petrograd?

You may blame Germany for what the Turks are doing. Can you also blame England or France for what Russia is doing? It also says that Russia is fighting for civilization. . . . I am not pro-German, as I am against militarism, but if that is the kind of civilization Russia is fighting for, then I am "German Kultur." Six Million Jews Are Deprived Of Papers By Russian Censorship

Petrograd, Russia, April 22.—After a spirited fight the Duma has passed the censorship bill, which was introduced to limit the powers of the censor, but in the form in which it was adopted actually increases them. The debate over the bill was extremely bitter and the members of the opposition parties attacked the government and the papers controlled by it savagely. Har-kow, the leader of the "cadets," and the socialist deputy adlemow accused the government of bribing the editors and publishers of all large dailies and offered proof for their charge.

The progressive deputy Bomach created a sensation by producing a secret circular sent out by the minister of the interior which instructed the police to suppress all Jewish publications, even if not printed in Yiddish.

"**Six million Jews** have been robbed of their newspapers," the deputy said. "The only Jewish papers still tolerated are a few insignificant weeklies which support the government, because they are paid for doing so. Not one of the suppressed seven Jewish dailies, hundreds of weekly and monthly papers committed the slightest offense. They did not antagonize the government, but were loyal without a single exception."

"The only reason for their suppression was the anti-Semitic spirit which dominated the authorities from cabinet ministers down. This spirit is also responsible for the fact that the post-offices have been ordered to destroy all letters and postal cards written in Yiddish."

Millions Needed For Jewish Relief Work in Poland

New York Committee Seeks More Funds as Result of Destruction of Towns During the Present War

All the relief work of the joint distribution committee among the Jews of Poland, in which several millions of dollars were expended, has been nullified by the war between the Soviet and Polish armies, according to reports received by Judge Otto A. Rosalsky, chairman of the Greater New York Campaign for Jewish War Sufferers Abroad.

The committee faced the task of raising additional millions of dollars as a result of the war in Poland. Relief work in Warsaw and towns in the fighting zone has been temporarily abandoned. Many of the communities had been virtually restored, but all this reconstruction work has been wiped out, the chairman has learned from his representatives in Europe.

"It is an old truth that whoever fights the Jew is the sufferer," Judge Rosalsky said yesterday. **Six million Jews** were made homeless by five years of foreign and domestic wars. Through the joint distribution committee to raise funds for which the greater New York campaign was organized, we had succeeded in restoring them in some measure to normal health and economic independence.

RUSSIAN JEWS.

A correspondent of Emanuel-EI, a paper edited by Rabbi Vorsanger of San Francisco, gives a pitiful picture of the condition of the Jews in Russia. He says that poverty, starvation and disease are the afflictions which now beset the **six million Jews** in that country and Roumania. The government does afford some modicum of relief to the starving Russian moujik and laborer; but for the Jew there is no charity, no mercy. The little assistance which used to come from America and England is diminishing daily. Part of the money sent by relatives who have emigrated is stolen in transmission, whilst those who could make sure that their doles would reach their destination are unemployed, and "sweated" when they work, and are no longer able to render any assistance. The revolutionary movement has destroyed the industries in the Pale. Thus, for instance, whilst the factories at Lodz are not working, or only working half time, the Russian factories at Moscow have been over busy. But in Moscow there are not any Jewish workers. What is to become of the mass of the Jewish population in Russia is beyond man's ken. It is useless to look for the causes when a calamity is staring in the face. It is useless to point out that early and imprudent marriages are one of the causes of the great poverty. (64-66), the last but also worst procurator, who made an ostentatious display of his oppressions. Disturbances in the streets of Jerusalem and Caesarea were now of frequent occurrence, and massacre followed upon massacre. All attempts at peace-making on the part of Agrippa I. and of the peace party were in vain. The patience of the people had been taxed too much, and Judea was at open war with the Emperor Nero, who sent his first general of the empire, Vespasian, to subjugate Palestine. Under Titus, Vespasian's general, fortress after fortress surrendered until at last Jerusalem was taken and the temple burned to the ground, August 10, 70 A. D.

Judea was now a waste, Jerusalem a heap of ruins, and there was no Jeremiah to sing the funeral dirge of the city of David and Solomon. Directly after the triumph of Titus the Sanhedrin met at Jamnia or Jabneh, and in the hands of this council the work of transforming and adapting Judaism to the altered political circumstances, proved a task of little difficulty. Jamnia had only to be substituted for Jerusalem, a few ordinances to be discontinued or slightly altered, and certain prayers or good works to be substituted for the sacrifices, and the change was effected without leaving any trace of violent revolution. The spiritual head of the Jamnian commonwealth was Gamaliel II.¹ National fanaticism, indeed, was not yet extinguished; but it burnt itself completely out in the vigorous insurrection led by Bar-Cocheba, the pseudo-messiah, in which nearly six million Jews lost their lives, together with the




Portrait of Gamaliel II. in the Sanhedrin.

famous Rabbi Akiba, one of the pseudo-messiah's most ardent adherents (135 A. D.). Titus, to annihilate forever all hopes of the restoration of the Jewish kingdom, accomplished his plan by establishing a new city on the site of Jerusalem, which he called *Ælia Capitolina*. An edict prohibited any Jew from entering the new city on pain of death. More effectually to keep them away, the image of a swine was placed over the gate leading to Bethlehem. The seat of the spiritual head, or patriarch, also called *nasi*, was now transferred from Jamnia to Tiberias, where Judah the Holy completed in A. D. 190 the collection of all the oral or traditional laws, called the *Mishna*. When in the fifth century (429) Palestine ceased to be the centre of Judaism, Babylonia took her place. From the period of the exile a numerous and coherent body of Jews had continued to subsist there. The Parthians and Sassanides granted them self government. At their head was a native

prince, the *Rish Galutha*, i. e., prince of the captivity, who, when the Palestinian patriarchate came to an end, was left without a rival. The schools there at Pumbeditha, Sora, and Nahardea prospered greatly, developed rabbinism, vied with those of Palestine, and continued to exist after the cessation of the latter, when the patriarchate became extinct; thus they had the last word in the settlement of doctrine, which was embodied in the celebrated Babylonian Talmud, compiled about the year 500. When the schools at Pumbeditha and Sora were closed Jewish learning was transferred to Spain.

Returning to the Jews in the Roman Empire, we find that after the reign of Vespasian and Hadrian the condition of the Jews was not only tolerable, but in many respects prosperous. But the complete reverse took place after the conversion of Constantine. The Jews, who formerly had taken a great share in the persecution of the Christians by pagan Rome, now became a condemned and

SEVILLE, April 12.—All Spaniards venerate the name of Isabel la Catolica, nor is the impressionable De Amicis the only foreigner who has trembled and wept before the enshrined memorials, jewel box, mirror, missal, and crown of her royal womanhood. She is a precious figure in poor Spain's sunset revery—a saint beneath a conquering standard, a silken lady in a soldier's tent. Yet this peerless, Queen, merciful, magnanimous, devout, "the shield of the innocent," caring supremely for the glory of God and the good of her country, gave consent, albeit reluctant, to the establishment of the Inquisition, Christianity's chief scandal and Spain's most fatal blight. So ironic were the stars of Isabel.
